## BC HONDA DEALERS DREAM GARAGE CONTEST

## THIS CONTEST IS OPEN TO BRITISH COLUMBIA RESIDENTS ONLY AND IS GOVERNED BY CANADIAN LAW

### 1. CONTEST PERIOD:

The Contest (the "Contest") begins on March 1, 2018 and ends on April 30, 2018 (the "Contest Period").

# 2. ELIGIBILITY:

Contest is open to residents of British Columbia who are nineteen (19) years of age or older at the time of entry, except employees, representatives or agents (and those with whom such persons are domiciled, whether related or not) of British Columbia Honda Dealers Association (the "**Sponsor**"), Honda Canada Inc., their respective parent companies, subsidiaries, affiliates, prize suppliers, dealers, advertising/promotion agencies and any entity involved in the development, production, implementation, administration, judging or fulfillment of the Contest (collectively, the "**Contest Parties**").

#### **3.** HOW TO ENTER:

There are two (2) ways to enter the Contest, as follows:

**<u>PURCHASE</u>**: An eligible entrant will automatically earn one (1) entry (the "**Entry**") when he/she purchases, leases or finances a new previously unregistered 2018 Honda vehicle (each, an "**Eligible Vehicle**") from a British Columbia Honda Dealer during the Contest Period (each, an "**Eligible Transaction**"). The decisions of the Sponsor with respect to all aspects of this Contest are final and binding on all entrants without right of appeal, including, without limitation, any decisions regarding the eligibility/disqualification of Entries, Eligible Vehicles, Eligible Transactions and/or entrants.

**NO PURCHASE NECESSARY**: To obtain one (1) Entry in the Contest without completing an Eligible Transaction, print your first name, last name, telephone number, complete mailing address (including postal code), age and signature on a plain white piece of paper and mail it (in an envelope with sufficient postage) along with a 50-150 word unique and original essay stating why you would like to drive a new 2018 Honda vehicle to: British Columbia Honda Dealers Association. Attn. Western Zone Honda Sales Manager, Honda Canada Inc. 13240 Worster CT, Richmond, BC V6V 2B8 (collectively, the "**Request**"). Upon receipt of your Request in accordance with these Official Rules and Regulations (the "**Rules**"), you will receive one (1) Entry in the Contest. To be eligible, your Request must: (i) be received separately in an envelope bearing sufficient postage (i.e. mass mail-in Requests in the same envelope will be void); and (ii) be post-marked during the Contest Period and received prior to the Draw Date (defined below). Your Request will be time-stamped based on when it is received by the Sponsor (i.e. not when it is post-marked). The Released Parties (defined below) take no responsibility for any lost, stolen, delayed, illegible, damaged, misdirected, late or destroyed Requests (all of which are void).

### 4. ENTRY LIMIT:

There is a limit of one (1) Entry per Eligible Transaction during the Contest and a limit of two (2) no-purchase mail-in entries per person. If it is discovered by the Sponsor (using any evidence or other information made available to or otherwise discovered by the Sponsor) that any person has attempted to: (i) obtain more than one (1) Entry; and/or (ii) use multiple names and/or identities to enter or otherwise participate in or disrupt this Contest; then he/she may be disqualified from the Contest in the sole and absolute discretion of the Sponsor. The Released Parties (defined below) are not responsible for late, lost, misdirected, delayed, incomplete or incompatible Entries (all of which are void).

### 5. VERIFICATION:

All Entries, Requests, Eligible Transactions, Eligible Vehicles and entrants are subject to verification at any time and for any reason. The Sponsor reserves the right, in its sole and absolute discretion, to require proof of identity and/or eligibility (in a form acceptable to the Sponsor – including, without limitation, government issued photo identification): (i) for the purposes of verifying an individual's eligibility to participate in this Contest; (ii) for the purposes of verifying the eligibility

and/or legitimacy of an Entry, Request, Eligible Transaction and/or other information for the purposes of this Contest; and/or (iii) for any other reason the Sponsor deems necessary, in its sole and absolute discretion, for the purposes of administering this Contest in accordance with the letter and spirit of these Rules.

Failure to provide such proof to the complete satisfaction of the Sponsor within the timeframe specified by the Sponsor may result in disqualification in the sole and absolute discretion of the Sponsor. The sole determinant of the time for the purposes of this Contest will be the Sponsor's Official Clock.

#### 6. THE PRIZES AND THEIR APPROXIMATE RETAIL VALUE:

At the end of the Contest Period, there will be thirty (30) prizes (each, a "Prize" and collectively, the "Prizes") available to be won, each consisting of one (1) Honda HRR Smart-Drive Electric-start lawnmower (Model No. HRR2169VLC) with an approximate retail value of seven hundred eighty nine dollars (\$789 CAD). Each Prize must be accepted as awarded and is not transferable or assignable (except as may be specifically permitted by Sponsor in its sole and absolute discretion). No substitutions except at Sponsor's option. Sponsor reserves the right, in its sole and absolute discretion, to substitute any Prize with a prize or prizes of equal or greater retail value for any reason.

## 7. WINNER SELECTION AND ODDS OF WINNING:

On or around May 5, 2018 (the "**Draw Date**") in Vancouver, British Columbia, thirty (30) eligible Entries will be selected by random draw from among all eligible Entries submitted and received in accordance with these Rules. The odds of winning depend on the number of eligible Entries submitted and received in accordance with these Rules.

## 8. WINNER NOTIFICATION:

The Sponsor or its designated representative will make a minimum of three (3) attempts to contact each selected entrant within five (5) business days of the Draw Date. If a selected entrant cannot be contacted within five (5) business days of the Draw Date, or if there is a return of any notification as undeliverable; then he/she may, in the sole and absolute discretion of the Sponsor, be disqualified (and, if disqualified, will forfeit all rights to a Prize) and the Sponsor reserves the right, in its sole and absolute discretion and time permitting, to randomly select an alternate eligible entrant from among the remaining eligible Entries submitted and received in accordance with these Rules (in which case the foregoing provisions of this section shall apply to such newly selected entrant).

### 9. WINNER CONFIRMATION:

BEFORE BEING DECLARED A CONFIRMED PRIZE WINNER, each selected entrant will be required to: (a) correctly answer a mathematical skill-testing question without mechanical or other aid; and (b) sign and return within five (5) business days of notification the Sponsor's declaration and release form, which (among other things): (i) confirms compliance with these Rules; (ii) acknowledges acceptance of the Prize (as awarded); (iii) releases the Contest Parties and each of their respective officers, directors, agents, representatives, successors and assigns (collectively, the "Released Parties") from any and all liability in connection with this Contest, his/her participation therein and/or the awarding and use/misuse of the Prize or any portion thereof; and (iv) agrees to the publication, reproduction and/or other use of his/her name, address, voice, statements about the Contest and/or photograph or other likeness without further notice or compensation, in any publicity or advertisement carried out by or on behalf of the Sponsor in any manner whatsoever, including print, broadcast or the internet. The Released Parties will not be liable for the failure of any Entry, Request, Eligible Transaction or other information to be received, captured or recorded for any reason. The Sponsor reserves the right, in its sole and absolute discretion, to disqualify any individual that it deems to be in violation of these Rules. The Sponsor reserves the right to refuse an Entry or Request from any person whose eligibility is in question or who has been disqualified or is otherwise ineligible to enter. In its sole and absolute determination, the Sponsor may disqualify any person who acts in any manner to threaten or abuse or harass any person and to void all such person's Entries.

The Sponsor reserves the right, in its sole and absolute discretion, to withdraw, amend or suspend this Contest (or to amend these Rules) in any way, in the event of an error, problem, tampering, unauthorized intervention, fraud, failure or any other cause beyond the reasonable control of the Sponsor that interferes with the proper conduct of this Contest as contemplated by these Rules. The Sponsor reserves the right, in its sole and absolute discretion, and without prior notice, to adjust any of the dates and/or timeframes stipulated in these Rules, to the extent necessary, for purposes of verifying compliance by any entrant, Entry, Request and/or Eligible Transaction with these Rules, or as a result of any problems, or in light of any other circumstances which, in the opinion of the Sponsor, in its sole and absolute discretion, affect the proper administration of the Contest as contemplated in these Rules, or for any other reason.

In the event of any discrepancy or inconsistency between the terms and conditions of these Rules and disclosures or other statements contained in any Contest-related materials, including, but not limited, to point of sale, television, print or online advertising, any instructions or interpretations of these Rules given by an employee of the Sponsor or any dealer; the terms and conditions of these Rules shall prevail, govern and control to the fullest extent permitted by law.

All issues and questions concerning the construction, validity, interpretation and enforceability of these Rules or the rights and obligations of participants, Sponsor or any of the other the Released Parties in connection with the Contest will be governed by and construed in accordance with the domestic laws of the Province of British Columbia and the federal laws of Canada applicable therein, without giving effect to any choice of law or conflict of law rules or provisions that would cause the application of any other jurisdiction's laws. Entrants hereby consent to exclusive jurisdiction and venue of the courts located in British Columbia in any action to enforce (or otherwise relating to) these Rules or relating to this Contest.

The invalidity or unenforceability of any provision of these Rules shall not affect the validity or enforceability of any other provision. In the event that any provision is determined to be invalid or otherwise unenforceable or illegal, these Rules shall otherwise remain in effect and shall be construed in accordance with the terms as if the invalid or illegal provision were not contained herein.
